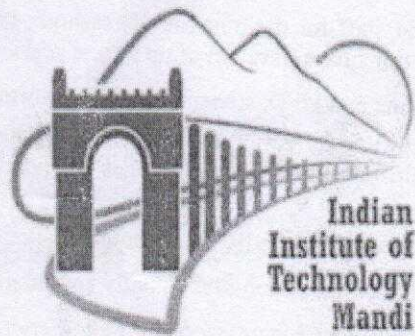


# Memorandum of Understanding

**This Memorandum of Understanding made between:**

**Jaypee University of Information Technology (JUIT), Solan** was conceived by a joint vision of the Govt of Himachal Pradesh and the Founder Chairman of Jaypee Group Shri JaiPrakash Gaur in 2000. Land was provided on lease by the State Govt and the university was established by Act No 14 of 2002 vide Extraordinary Gazette Notification of the Govt of Himachal Pradesh dated May 23, 2002. The University Grants Commission accorded its approval under Section 2(f) of the UGC Act vide their Letter No. F 9-10/2002(CPP-1) dated 09 Dec 2002. The JUIT is also a member of the Association of Indian Universities (AIU).

&

**Indian Institute of Technology (IIT Mandi), Mandi 175075, Himachal Pradesh.** The institute became an IIT under The Institutes of Technology (Amendment) Act, 2011, with the intention to expand the reach and to enhance the quality of technical education in the country. The Act was passed in the Lok Sabha on 24 March 2011 and by the Rajya Sabha on 30 April 2012.

**Objectives of Memorandum of Understanding**

To promote and support academics and research for the development of excellence in both the institutions, the two institutions have agreed to cooperate in the following main activities:

- Exchange visits of faculty and staff for the purpose of research, teaching and consultancy with prior approval from both the institutions for a duration of up to one year.  
Joint supervision of postgraduate and Ph.D. students as per the norms of both the institutions.
- Permissible exchange of scientific information for academic purposes.
- Utilization of research facilities at special usage charges applicable for registered users of both the institutions.
- Training of students on facilities at both institutes subject to availability of resources.
- Joint research activities through participation in nationally and internationally funded projects.
- Organization of joint events such as seminars, workshops, conferences, training programs, etc.
- Exchange of students for 1 or 2 semesters for course work and projects with the possibility of transfer of credits as per the norms of the institutions.
- Any other objective as agreed in writing by both the institutions.

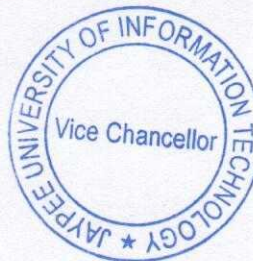
**1. Financial Arrangements:**

Both the parties acknowledge and understand that all financial arrangements, if any, will be subjected to prior written agreement and availability of funds for each activity undertaken.

**2. Duration renewal:**

The MoU is signed initially for **five years** at the first instance from the date of signing. Further continuance of this MoU will be subject to joint agreement and review by both parties to be undertaken before the expiry of this MoU.

3. **Advertising and Publicity:**

Both the institute may advertise this MoU for information of students, faculty, staff and the general public.

4. **Modification of MoU:**

This MoU may be modified at any time if circumstances arise which call for any alteration, subject to the approval of both parties.

5. **Statutory Compliance:**

This MoU solely expresses the intention of both institutions. It is agreed that it does not have a legal effect nor create any financial obligations on either institution.

6. **Confidentially:**

Both institutions agree and undertake to keep confidential any information/data exchanged, acquired, or shared in connection with any program or activity conducted under this MoU.

7. **Governance:**

All terms of this MoU are subject to the laws of the Republic of India and acts, statutes and ordinances of both the institutions.

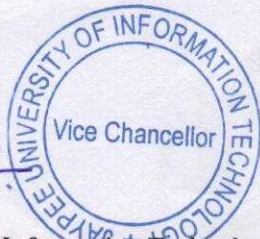
8. **Signature on MoU:**





